Members will have the ability to rent cabins within the North Hunt Club area as well as dry camping at the Vaquero Campground located adjacent to the Old Headquarters Entrance (Sebastian Road). All lodging opportunities will be subject to availability. *All cabin lodging requires a two (2) night stay beginning on Monday, Wednesday or Friday. (50% deposit required on all reservations.)*

- <u>Cazador Lodge</u> (North)
 - Located off the Haul Road approximately 8 miles from the Old Headquarters Entrance. This lodge has a fully equipped kitchen, sleeps twelve (12), all the basic amenities and may be rented for \$400 + tax per night.
- Bloom House (North)
 - Located just inside the Old Headquarters entrance. This house has a fully equipped kitchen, sleeps fourteen (14), all the basic amenities and may be rented for \$400 + tax per night.

- All pig hunting members must have valid stamped Tejon Ranch pig tags issued through the Wildlife Management Office prior to entering the Ranch. Each member or guest must complete a tag upon harvest and return to the Wildlife Management Office or leave in sign in seat upon departure.
- Tejon Ranch reserves the right to guide hunting trips on entire Hunt Club area and the right to access and use all facilities within the area; there will also be other ranch activities, including but not limited to filming, public access events, and development planning activity that may limit access to portions of the Hunt Club area periodically. Tejon Ranch reserves the right to add, alter or cancel memberships at any time.
