Details of 2025 Spring North Small Game Access Package

- Season: March 1, 2025 through July 31, 2025.
- \$1,950 for Individual Package
- \$2,500 for Family Package (*Includes spouse and dependents under 26 years of age*)
- \$1,000 Pig Option
 - Allows harvest of one (1) boar during spring season
- Includes twenty (20) guest passes, each valid for twenty-four (24) hours or ten (10) passes valid for forty-eight (48) hours
 - Additional twenty-four (24) hour guest passes may be purchased for \$125 each; forty-eight (48) hour guest pass \$175 each (limit 5 total per season, per membership)
 - Same guest may only accompany member 3 times per season

Membership includes the following:

- Small game hunting* across the entire South Hunt Club area (See note below)
- Fishing (catch & release only) on the designated ponds and waterways throughout the entire North Hunt Club area
 - Reservoir 2 Boats with trolling motor only, **NO WAKE**, may be used. Boats may be left at the reservoir in the designated area for \$250 per season. Tejon Ranch Company is not liable for any theft or damage to boats left on property.
- One boar if pig option selected

Lodging and Camping Members in the North & South Hunt Club will have the ability to use cabins within both hunt club areas, seasonal camp opportunities (Oso and Canary Camp), as well as dry camping at the campsites located at Crane Canyon and Vaquero. All the lodging opportunities will be subject to availability. **All cabin lodging requires a two-night stay beginning on Monday, Wednesday or Friday.**

- **Cazador Cabin (North)** is located off Haul Road approximately 8 miles from the Old Headquarters Entrance. This cabin has a fully equipped kitchen, 3 bedrooms, 2 bathrooms, sleeps 12, all the basic amenities and can be rented for \$400 + tax per night.
- **Bloom House (North)** is located just inside the Old Headquarters Entrance. This house has a fully equipped kitchen, 4 bedrooms, 2 bathrooms, sleeps 14, and all the basic amenities and can be rented for \$400 + tax per night.
- **Cross & Crescent House (Lebec)** is located near the Ranch main headquarters, approximately three miles from the Lebec entrance gate and fourteen miles to the Sebastian entrance gate. This house has a fully equipped kitchen, 4 bedrooms, 3 bathrooms, sleeps 7, all the basic amenities and can be rented for \$425 + tax per night.
- **Vaquero Campground (North)** is available for RV's and trailers. This is a dry campground with no hookups. There are limited spots available and will be based on a first-come, first-serve basis. All RV's and trailers will need to be removed at the end of each stay. ****Note: RV's and trailers may be kept at the Vaquero Campground for \$500.00 per season.***

- All members, family members and guests (hunting or non-hunting) must always have in their possession a valid hunting and/or access permit while on Ranch property.
- All members, family members and guests must purchase liability insurance from Tejon Ranch at the rate of \$35.00 per year (September 1-July 31) prior to entering the Ranch. Each person, hunting or not, must carry the insurance. (No Exceptions)
- Tejon Ranch reserves the right to guide hunting trips on entire Ranch and the right to access and use all facilities within the area; there will also be other ranch activities, including but not limited to filming, public access events, and development planning activities that may limit access to portions of the Ranch periodically. Tejon Ranch also reserves the right to add, alter or cancel memberships at any time.
- No ATV's, motorcycles, quads or off-road vehicles are permitted on Tejon Ranch at any time. **NO EXCEPTION.** 4x4 vehicles are allowed.
